INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (the “Assignment”), dated as of January 22, 2024, is by and between WORLD WRESTLING ENTERTAINMENT, LLC, a Delaware limited liability company, formerly known as World Wrestling Entertainment, Inc., a Delaware corporation, who was formerly known as World Wrestling Federation Entertainment, Inc., a Delaware corporation (“Assignor”) and DJIP, LLC, a Florida limited liability company, with its principal place of business located at 9100 Wilshire Blvd., #1000W, Beverly Hills, CA 90212, (“Assignee”).

WHEREAS, Assignor is the owner of the Rock IP and all rights (now or hereafter known or devised) under any and all Intellectual Property Rights, including, but not limited to, the Rock Registered IP (as defined in the IP Agreement) listed on the attached Schedules A and B (the “Assigned IP”); and

WHEREAS, Assignor and Assignee have entered into an IP Assignment Agreement of even date herewith (the “IP Agreement”) pursuant to which Assignor has agreed to assign all right, title and interest in and to the Assigned IP, including any and all goodwill of the business associated with the use of, and symbolized by the Assigned Trademarks and Assigned Domain Names (as defined below), and the parties wish to record such assignment in the respective Patent and Trademark Offices and domain name registrars.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by Assignor and Assignee, Assignor and Assignee agree as follows:

1. Assignment of Trademarks. Effective as of the date hereof, and pursuant to the IP Agreement, Assignor assigns, conveys, sells, and transfers to Assignee and Assignee accepts all right, title and interest of Assignor in and to the “Rock IP” and the “Intellectual Property Rights” therein, which terms are defined in Schedule A-1 hereto, including the trademark applications and registrations and the logos set forth in Schedule A-2 hereto, together with (a) the goodwill of the business symbolized thereby; (b) all renewals and extensions of any such application, registration and filing; (c) all rights to sue for past, present, and future infringements, misappropriation, dilution, unfair competition or other violations of the foregoing, including the sole, exclusive and independent right to enforce and settle suits involving claims and demands for royalties, damages, and payments owing; and (d) all rights corresponding to any of the foregoing throughout the world (collectively, the “Assigned Trademarks”).
2. Assignment of Domain Names. Effective as of the date hereof, and pursuant to the IP Agreement, Assignor transfers, conveys, assigns and delivers to Assignee and Assignee accepts all right, title and interest of Assignor in and to the Internet domain names set forth in Schedule B hereto, including all Intellectual Property Rights that Assignor may have acquired in the domain names together with the goodwill symbolized thereby (the “Assigned Domain Names”). Assignor shall assist Assignee in transferring control of the Assigned Domain Names to Assignee, or its designee, and shall authorize the transfer of the Assigned Domain Names from Assignor’s present registrar to the Assignee’s designated registrar or account. Assignor further agrees to authorize Assignee to do such


things or file such documents as may be necessary to maintain the validity and enforceability of the Assigned Domain Names and corresponding registration pending full and complete transfer of such to Assignee.

3. Successors. This Assignment shall inure to the benefit of and is binding upon the respective successors and assigns of Assignor and Assignee.
4. Governing Law. This Assignment shall be governed by and construed in accordance with (a) the laws of the United States, in respect to trademark and copyright issues, and (b) in all other respects, including as to validity (except for trademark and copyright issues), interpretation and effect, by the laws of the State of California without giving effect to the conflict of laws rules thereof.
5. Counterparts. This Assignment may be executed in separate counterparts, each of which is deemed to be an original and all of which taken together constitute one and the same agreement.
6. Further Assurances. Assignor agrees, at Assignee's expense, to take all further actions, and provide to Assignee and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as Assignee and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Assignment in the name of the Assignee, including assisting Assignee with updating the chain of title records for the respective Patent and Trademark Offices, and domain name registrars in order to evidence a clean and direct chain of title to Assignee. Further, Assignor will assign the PROJECT ROCK U.S. application no. 87671569 to Assignee once an amendment to allege use or statement of use has been filed and accepted by the United States Patent and Trademark Office.
7. Miscellaneous. This Assignment is subject to all the terms and conditions of the IP Agreement. The parties intend that this Assignment is for recordation purposes only and its terms shall not modify the applicable terms and conditions of the IP Agreement. In the event of any inconsistency between the provisions of this Assignment and the IP Agreement, the provisions of the IP Agreement will prevail.
