

Partial Assignor further assigns to Partial Assignee one half of its rights to sue for and receive all damages occurring from past infringing uses of the Mark.

This Partial Assignment shall be binding on the parties, their successors and/or assigns and all others acting by, through, with, or under their direction, and all those in privity therewith.



