**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (“Release”) is made as of this 20th day of November 2023, by JPMORGAN CHASE BANK, N.A., a national banking association, in its capacity as Lender (“Lender”), in favor of BEYOND BETTER FOODS, LLC, a Delaware limited liability company, (“Grantor”).

WHEREAS, Grantor entered into a certain Intellectual Property Security Agreement, dated November 20, 2020, with Lender, notice of which was recorded with the United States Patent and Trademark Office (“USPTO”) on December 7, 2020, at reel/frame 7125/0281 (the “IP Security Agreement”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, Grantor granted to Lender, under the terms of the IP Security Agreement, a security interest in favor of Lender, in and to all of their right, title and interest in and to the Intellectual Property Collateral, including without limitation the trademarks (the “Trademarks”), patents (the “Patents”), and copyrights (the “Copyrights”, together with the Trademarks and Patents, collectively, the “IP Collateral”) listed on Schedule 1.

WHEREAS, Lender has agreed to terminate and release its security interest in all such IP Collateral as herein provided.


FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Lender hereby (a) releases, terminates and discharges its security interest in the IP Collateral, including the Trademarks, Patents, and Copyrights listed on Schedule 1 attached hereto and made a part hereof, (b) terminates the IP Security Agreement and (c) assigns, transfers and conveys to Grantor any right, title or interest, including the security interest, it may

have in the IP Collateral. Grantor, or any successor to Grantor (including any person or entity hereafter having any right, title, or interest in or to the IP Collateral), is hereby authorized to record this Release with the USPTO.
