Release of Security Interest in Specified Trademarks

This Release of Security Interest in Specified Trademarks (the “Release”) is made as of February 1, 2024, by HPS INVESTMENT PARTNERS, LLC, in its capacity as collateral agent (the “Collateral Agent”) pursuant to the Security Agreement, dated as of April 15, 2021 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) in favor of SEACOR Holdings Inc. and Seacor Inland River Transport Inc. (each a “Pledgor” and collectively the “Pledgors”).

W I T N E S S E T H:

WHEREAS, pursuant to the terms and conditions of the Security Agreement in favor of the Collateral Agent, the Pledgors entered into that certain Intellectual Property Security Agreement, dated as of April 15, 2021 (the “Trademark Security Agreement”);

WHEREAS, pursuant to the terms and conditions of the Trademark Security Agreement and the Security Agreement, the Pledgors pledged and granted to the Collateral Agent for the benefit of the secured parties a lien on and security interest in all of the right, title and interest of the Pledgors in, to and under certain Trademarks (as defined in the Security Agreement), including those set forth on Schedule I attached hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 16, 2021 at Reel/Frame 007258/0165; and

WHEREAS, the Collateral Agent desires to release, terminate, discharge and relinquish the security interest and lien solely with respect to the Trademarks set forth on Schedule I attached hereto (the “Released Trademarks”).

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent on behalf of itself and the secured parties, hereby releases, terminates, discharges and relinquishes unto the Pledgors the continuing security interest in, and lien on, the Released Trademarks and otherwise assigns, grants and conveys to the Pledgors, without recourse, any and all right, title and interest the Collateral Agent or the secured parties may have in, to or under to the Released Trademarks in order to revest in the Pledgors full and unencumbered title to said Released Trademarks.



The Collateral Agent retains all security interests, liens, rights, titles and interests pledged and granted to the Collateral Agent under the Security Agreement and the Trademark Security Agreement with respect to all such other collateral, and the Collateral Agent’s security interest, liens, rights, titles and interests in such other collateral shall not, and shall not be deemed to, be impaired, interrupted or otherwise modified in any respect by this Release.

The Pledgors, or any successor to the Pledgors (including any person or entity hereafter having any right, title or interest in or to the Released Trademarks), is hereby authorized to record this Release in the United States Patent and Trademark Office.


