Release of Security Interest in Intellectual Property

This Release of Security Interest in Intellectual Property (the “Release”) is made as of February 7, 2024, by HPS INVESTMENT PARTNERS, LLC, in its capacity as collateral agent (the “Collateral Agent”) pursuant to the Security Agreement, dated as of April 15, 2021 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) in favor of SEACOR Holdings Inc. (the “Pledgor”).

W I T N E S S E T H:

WHEREAS, pursuant to the terms and conditions of the Security Agreement in favor of the Collateral Agent, the Pledgor entered into that certain Intellectual Property Security Agreement, dated as of April 15, 2021 (the “IP Security Agreement”);

WHEREAS, pursuant to the terms and conditions of the IP Security Agreement and the Security Agreement, the Pledgor pledged and granted to the Collateral Agent for the benefit of the secured parties a lien on and security interest in all of the right, title and interest of the Pledgor in, to and under the Intellectual Property Collateral (as defined in the Security Agreement), including those set forth on (i) Schedule I attached hereto (the “Trademarks”) and (ii) Schedule II attached hereto (the “Copyrights”);

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on April 16, 2021 at Reel/Frame 007258/0165; and

WHEREAS, the Collateral Agent desires to release, terminate, discharge and relinquish the security interest and lien in the Intellectual Property Collateral, the Trademarks and the Copyrights, including the Trademarks set forth on Schedule I attached hereto and the Copyrights set forth on Schedule II attached hereto.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent on behalf of itself and the secured parties, hereby releases, terminates, discharges and relinquishes unto the Pledgor the continuing security interest in, and lien on, the Intellectual Property Collateral, the Trademarks and the Copyrights, including the Trademarks set forth on Schedule I attached hereto and the Copyrights set forth on Schedule II attached hereto and otherwise assigns, grants and conveys to the Pledgor, without recourse, any and all right, title and interest the Collateral Agent or the secured parties may have in, to or under to the Intellectual Property Collateral, the Trademarks and the Copyrights, including the Trademarks set forth on Schedule I attached hereto and the Copyrights set forth on Schedule II attached hereto in order to revest in the Pledgor full and unencumbered title to said the Intellectual Property Collateral, the Trademarks and the Copyrights, including the Trademarks set forth on Schedule I attached hereto and the Copyrights set forth on Schedule II attached hereto.

The Pledgor, or any successor to the Pledgor (including any person or entity hereafter having any right, title or interest in or to the Intellectual Property Collateral, the Trademarks and the Copyrights), is hereby authorized to record this Release in the United States Patent and Trademark Office.
