**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of February 7, 2024, is made by ANTARES CAPITAL LP, as Collateral Agent (in such capacity, the “Agent”) in favor of OURHEALTH, LLC, an Indiana limited liability company (the “Grantor”). Capitalized terms used but not defined herein have the meanings given to them in the Trademark Security Agreement (as defined below), whether defined directly therein or by reference to another agreement.

WHEREAS, pursuant to that certain Collateral Agreement, dated as of October 7, 2019, by and between the Grantor, the Agent and certain other parties (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), the Grantor executed and delivered in favor of the Agent that certain Trademark Security Agreement, dated as of January 13, 2020 (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office (“USPTO”) on January 14, 2020 at Reel/Frame 6837/0501;

WHEREAS, pursuant to the Collateral Agreement and the Trademark Security Agreement, the Grantor granted to the Agent for the benefit of the Secured Parties, a security interest (the “Security Interest”) in all of its right, title and interest in, to and under the Trademark Collateral, including, without limitation, the Trademarks listed on Schedule I hereto; and

WHEREAS, the Grantor has requested that the Agent terminate and release its Security Interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (i) terminates and cancels the Trademark Security Agreement, (ii) terminates, cancels, discharges and releases its Security Interest in the Trademark Collateral and (iii) re-assigns to the Grantor any right, title or interest it may have in or to the Trademark Collateral, in each case without recourse to the Agent and without representation or warranty of any kind.

The Grantor, and any successor to the Grantor (including any person or entity hereafter holding any right, title or interest in and to the Trademark Collateral) is hereby authorized to record this Release with the USPTO.
