## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of February 6, 2024, by The Bank of Nova Scotia, a Canadian Public Banking Company, as Lender (the “Lender”), in favor of YB Media, LLC, a California Limited Liability Company (the “Grantor”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement (defined below).


FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, the Lender hereby unconditionally and expressly releases, terminates, and extinguishes its security interests in the Intellectual Property, including all of the Trademarks listed on Schedule A attached hereto and made a part hereof, which security interests were established under and pursuant to (i) that certain Security Agreement, dated as of March 30, 2022 (as from time to time amended, restated, supplemented, or otherwise modified, the “Security Agreement”), made by the Grantor in favor and for the benefit of the Lender, and (ii) that certain Intellectual Property Security Agreement, dated as of March 30, 2022 made by the Grantor in favor of the Lender (the “IP Security Agreement”), which the IP Security Agreement was recorded with the United States Patent and Trademark Office on April 5, 2022 at Reel 007680/Frame 0778.

The Lender consents and agrees to execute and deliver, at the request and cost of the Grantor, such further instruments, documents, and release forms as Grantor may reasonably request to more effectively release, terminate and extinguish any security interests upon the Intellectual Property.

This Release shall be binding upon the Lender’s legal representatives, assigns and successors.
