TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment (the "**Agreement**"), is made and effective as of January 31, 2024, ("**Effective Date**") by and between Hoptown Beer Bar Co. ("**Assignor**"), with an address at 9431 Bradmore Lane, Ste 101, Ooltewah, TN 37363, and Hootenanny Brewing Company, LLC ("**Assignee**") with an address at 107 Plantation Ridge Drive, P.O. Box 3878, Mooresville, NC 28117.

WHEREAS, Assignor is the owner of U.S. Trademark Registration No. 4,323,254 (the "**Registration**") for the mark HOPTOWN (the "**Mark**");

WHEREAS, Assignor and Assignee have entered into a certain Coexistence Agreement ("**Coexistence Agreement**"), dated on or about the date hereof, pursuant to which Assignor has assigned, or agrees to assign, to Hootenanny its entire right, title and interest in the Mark, the Registration, and all associated goodwill to Assignee and Assignee desires to accept assignment of the same; and

NOW, THEREFORE, in consideration of the premises and the mutual promises and covenants expressed herein, the Parties agree as follows:

1.1 In consideration of the premises set forth above and in the Coexistence Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, and transfers to Assignee, the entire right, title, and interest in and to the Mark, and the Registration, together with the good will symbolized by the Mark, and the right to sue and recover for past, present and future infringement.

1.2 Assignee acknowledges and agrees that the rights, title, and interests being assigned hereunder are being conveyed on an "as is," "where is" basis, and Assignor does and is not making any representations, warranties, or guarantees with respect to the Mark, the Registration, or any rights therein, whether express, implied, statutory, oral or in writing or otherwise, including, without limitation, any implied warranties of title, merchantability, fitness for a particular purpose, non-infringement, or warranties arising from a course of dealing, usage, or trade practice, and the same are hereby expressly disclaimed to the maximum extent permitted by law.

1.3 Each party agrees to execute and deliver such additional documents, and to perform such acts, as are reasonably requested by the other party to confirm, memorialize, effectuate or carry out the provisions of this Agreement.
