TRADEMARK ASSIGNMENT AGREEMENT

NOW, THEREFORE, BE IT KNOWN, pursuant to the Purchase Agreement, the Seller hereby conveys, assigns, transfers, delivers and sets over to Buyer, its successors and assigns, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all right, title and interest in and to any and all trademark rights and copyrights throughout the world, including any and all applications, registrations, and common law marks, together with the goodwill of the business associated with and symbolized by same, held by the Company immediately prior to the consummation of the Purchase Agreement, including those set forth in **Schedule A** hereto, together with all common law rights therein and the right to sue for past infringement of any and all of said trademarks and copyrights.




