RELEASE OF TRADEMARK SECURITY AGREEMENT

Dated: February 12, 2024

This Release of Trademark Security Agreement is made by **CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH**, as collateral agent (the “*Releasor*”), in favor of **SHEARER’S FOODS SA, INC.** (f/k/a Snack Alliance, Inc.), an Oregon corporation, **SHEARER’S FOODS, LLC**, an Ohio limited liability company, **SHEARER’S FOODS PERHAM, LLC** (f/k/a Barrel O’Fun Snack Foods Co., LLC), a Delaware limited liability company and **SHEARER’S FOODS BURLINGTON, LLC**, a North Carolina limited liability company (each a “*Grantor*” and together, the “*Grantors*”).

WHEREAS, by the First Lien Trademark Security Agreement, dated as of September 23, 2020 (the “*Security Agreement*”), recorded in the Trademark Assignment database of the United States Patent and Trademark Office (“*USPTO*”) on October 15, 2020 at Reel 007078 Frame 0100, each Grantor granted to the Releasor, a continuing security interest in all of each such Grantor’s right, title and interest in the Trademark Collateral (as defined in the Security Agreement), including the trademarks identified on Schedule 1 hereto (collectively, the “*Trademarks*”); and

WHEREAS, Releasor has agreed to release and discharge each Grantor from the terms and conditions set forth in the Security Agreement, and the parties wish to record with the USPTO the release of the security interest against the Trademarks.

NOW, THEREFORE, for good and valuable consideration, Releasor does hereby terminate, release and discharge (in each case without representation or warranty of any kind or nature, express or implied) the security interest, liens, and all other right, title or interest, if any, it may have in the Trademark Collateral, including the Trademarks identified on Schedule 1 hereto, and any right, title or interest of Releasor in the Trademark Collateral shall hereby cease and become void.


Releasor agrees to execute and deliver any document, and provide the Grantors with any


