TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of February 15, 2024, by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, in its capacity as collateral agent (in such capacity, together with its successors and assigns, the "Collateral Agent") in favor of SNOW SOFTWARE, INC., a Delaware Corporation (the "Grantor"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, the Grantor is party to that certain Guarantee and Collateral Agreement, dated as of July 7, 2021 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement");

WHEREAS, Grantor and Collateral Agent entered into that certain Trademark Security Agreement dated as of July 7, 2021 (the "Trademark Security Agreement"), pursuant to which the Grantor pledged and granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in and mortgage on all of its right, title and interest in, to and under all the following Collateral of the Grantor (all of the following items or types of property being herein collectively referred to as the "Trademark Collateral"):

- A. all Trademarks and Trademark Licenses (each as defined in the Guarantee and Collateral Agreement) of the Grantor including those listed on Schedule I attached hereto;
- B. all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and
- C. all products and proceeds (as that term is defined in the UCC) of the foregoing, including any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademarks exclusively licensed under any License, including right to receive any damages, (ii) injury to the goodwill associated with any Trademark, or (iii) right to receive license fees, royalties, and other compensation under any Trademark License.

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on July 7, 2021 at Reel 7348, Frame 0088;

WHEREAS, Collateral Agent now desires to terminate and release the entirety of its security interest in the Trademark Collateral; and

WHEREAS, Grantor has satisfied and fulfilled all of its obligations to release the Collateral Agent's security interest in the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

- 1. Collateral Agent hereby absolutely, unconditionally and irrevocably releases, terminates and forever discharges its security interest in all of Grantor's entire right, title and interest in, to and under the Trademark Collateral, and any right, title or interest of the Collateral Agent in such Trademark Collateral shall hereby cease and become void.

2. Collateral Agent hereby grants and conveys to the Grantor, without any representation, recourse or undertaking by Collateral Agent, any and all of Collateral Agent's right, title and interest in and to the Trademark Collateral.

3. Collateral Agent hereby authorizes and requests that this Trademark Release be recorded at the United States Patent and Trademark Office, or any other applicable location. Collateral Agent shall take all further actions, and provide to Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor, and at Grantor's cost and expense, to more fully and effectively effectuate the purposes of this Trademark Release.
