RECITALS

A. WHEREAS, Assignee assigned certain interests in the Intellectual Property Collateral (as defined in the Security Agreement (as defined below)), including the intellectual property described on Exhibit A and Exhibit B herein to Assignor pursuant to a certain Intellectual Property Security Agreement dated as of November 25, 2020 (the "Security Agreement"), which was recorded with the U.S. Patent and Trademark Office on November 25, 2020 at reel/frame 054472/0345 with respect to patent security interests and at reel/frame 7116/0011 with respect to trademark security interests.

B. WHEREAS, the Security Agreement has terminated, and Assignee has no outstanding obligations to Assignor that are secured under the terms of the Security Agreement; and

C. WHEREAS, Assignor wishes to release in full its security interest in the Intellectual Property Collateral (as defined in the Security Agreement), and to reassign, without warranty or recourse, all right, title and interest that Assignor may have in the Intellectual Property Collateral (as defined in the Security Agreement).

AGREEMENT


