Nunc Pro Tunc Trademark Assignment

WHEREAS, Wireless Watchdogs, LLC, a California limited liability company, with an address at 5800 Hannum Avenue, No. B, Culver City, California 90230 (the "Assignor"), owned United States Trademark Registration Nos. 3,061,911 and 3,052,754 for the marks WIRELESS WATCHDOGS - THE TIGHT LEASH ON WIRELESS COSTS and WIRELESS WATCHDOGS, respectively ("the Trademarks") and the goodwill associated therewith;

Assignor confirms that it has sold, assigned, transferred, and conveyed and does hereby sell, assign, transfer, and convey to Assignee all rights, title, and interest in and to the Trademarks, together with any common law rights and the goodwill of the business symbolized therewith, as well as the right (but not the obligation) to assert the Trademarks and to collect for all past, present and future infringements, and claims for damages and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits and all rights corresponding thereto throughout the world by reason of any past and future acts of infringement that have occurred or may occur, *nunc pro tunc* as of at least as early as July 19, 2021. Assignor also hereby represents that Assignee is the successor to the portion of Assignor's ongoing and existing business to which the Trademarks pertain.
