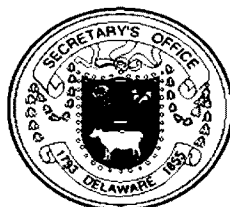

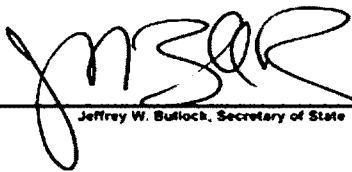

Pursuant to Title 8, Section 264(c) of the Delaware General Corporation Law (the “DGCL”) and Title 6, Section 18-209 of the Delaware Limited Liability Company Act (the “DLLC”) Havenly CZ, LLC, a Delaware limited liability company (the “Company”), in connection with the merger of The Citizenry, Inc., a Delaware corporation (the “Merger Sub”), with and into the Company (the “Merger”), hereby certifies as follows:

FIRST: The names and states of formation or incorporation of the constituent entities to the Merger are:

SECOND: An Agreement and Plan of Merger, dated as of February 21, 2024, by and among Merger Sub, the Company and other parties thereto (the “Merger Agreement”), setting forth the terms and conditions of the Merger, has been approved, adopted, certified, executed and acknowledged by each of the Company and Merger Sub in accordance with the requirements of Section 264 of the DGCL and Section 18-209 of the DLLC.

THIRD: The Company shall be the surviving entity in the Merger (the “Surviving Entity”), which will continue its existence as said Surviving Entity upon the effective date of the Merger.

FOURTH: The Certificate of Formation of the Surviving Entity shall be identical to the Certificate of Formation of Company immediately prior to the Merger, except that Article I of the Certificate of Formation of the Surviving Entity shall read as follows: “The name of this limited liability company is The Citizenry, LLC”.

FIFTH: The Merger shall become effective upon the filing of this Certificate of Merger with the Secretary of State of the State of Delaware.

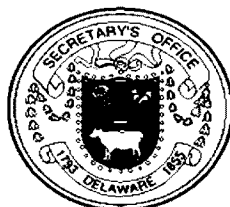

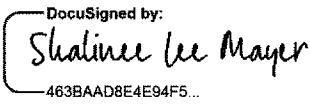
The undersigned authorized person, hereby certifies as follows:

Said Certificate requires correction as permitted by Section 18-211 of the Limited

3. The inaccuracy or defect of said Certificate is (must give specific reason):
Article the Fourth inaccurately listed the name of the Surviving Entity: it gave it the new name
"The Citizenry, LLC" rather than keeping the old name "Havenly CZ, LLC". This was because of
inaccurate language at the end of Article Fourth that said "except that Article I of the Certificate of
Formation of the Surviving Entity shall read as follows: "The name of this limited liability company
is The Citizenry, LLC"." This language needs to be deleted from Article Fourth. For the avoidance of doubt,
this Certificate of Correction has and is intended to have retroactive effect to the date and time of the
effectiveness of the Certificate of Merger and is not intended to operate as an amendment but rather as a
correction ab initio pursuant to Section 18-211 of the Limited Liability Company Act of the State of Delaware.

4. Article FOURTH of the Certificate is corrected to read as follows:
The Certificate of Formation of the Surviving Entity shall be identical to the Certificate of Formation of
Company immediately prior to the Merger.
