TRADEMARK ASSIGNMENT

WHEREAS, Assignee is the successor to that portion of the ongoing and existing business to which the Trademarks pertain; and

NOW, THEREFORE, for good and valuable consideration of US \$10.00, the receipt and legal sufficiency of which is hereby acknowledged, the parties agree as follows:

Assignment. Assignor hereby conveys, assigns, transfers, and delivers to Assignee its entire right, title and interest in and to the Trademarks together with all rights and privileges granted and secured thereby, including:

- (a) all rights and obligations under any license agreements governing use of the Trademarks;
- (b) all rights and obligations in and to all of the goodwill of the business associated with the Trademarks and the ongoing and existing business of the Assignor to which the Trademarks pertain; and
- (c) all claims for damages by reason of past or current infringement of same, with the right to sue for and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives.

This Assignment shall be binding upon and shall inure to the benefit of the respective successors and assigns of Assignor and Assignee.
