TRADEMARK ASSIGNMENT

WHEREAS, Salem Vent International, Inc., is a Virginia corporation, with an address of 3993 Daugherty Rd, Salem, VA 24153, (collectively "Assignor"), and Hansen International, Inc., is a South Carolina corporation, with an address of 130 Zenker Road, Lexington, SC, 29072 ("Assignee");

WHEREAS, On September 30, 2013, Assignor filed an application that was later registered as US Trademark Registration No. 4,647,660 for the mark "SALEM" (the "Trademark Registration"). The Trademark Registration claimed a date of first use and first use in commerce of at least as early as March 1, 1982;

WHEREAS, on June 17, 2013, Assignor and Assignee had executed an extensive commercial agreement incorporating a number of documents, including a Licensing and Technical Assistance Agreement, and an IP Assignment Agreement, which was escrowed for ten years;

WHEREAS, in the IP Assignment Agreement, Assignor agreed to assign and did in fact assign all of its right, title and interest in and to all trademarks related to Assignor's Products, which would include then-existing common law trademark rights later secured in the Trademark Registration; and

WHEREAS, the parties wish to ratify and confirm assignment, by Registration Number, of the Trademark Registration, pursuant at least to the IP Assignment Agreement;

NOW, THEREFORE, in view of the payment of legally sufficient and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor DOES HEREBY acknowledge the assignment and transfer to Assignee, nunc pro tunc to September 30, 2013, any and all right, title, and interest in and to the Trademark Registration, along with the goodwill and/or secondary meaning associated therewith, and rights to any and all renewals thereof, together with the right to bring suit and collect for infringements thereof (collectively, the "Trademark Rights").

Assignor does hereby agree, without further consideration, to execute any additional documents and take such further action as may be requested to vest in

Assignee good, valid, and marketable title to the Trademark Rights.

This Assignment and all terms hereof shall be binding upon and inure to the benefit of the parties and their respective heirs, personal and legal representatives, successors and assigns.
