SUPPLEMENTAL GRANT OF SECURITY INTEREST IN TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, each of The Orvis Company, Inc., a Vermont corporation, with its principal office at 178 Conservation Way, Sunderland, VT 05250 and Scientific Anglers LLC, a Michigan limited liability company, with its principal office 4100 James Savage Rd, Midland, MI 48642 (each, a “Grantor” and collectively, the “Grantors”), hereby grants to BANK OF AMERICA, N.A., a national banking association with its principal office at 100 Federal Street, Boston, Massachusetts 02110 (the “Grantee”), a continuing security interest in and lien upon the following (except as such may be considered Excluded Property): (i) all of such Grantor’s right, title and interest in, to and under to the trademarks, trademark registrations and trademark applications set forth on Schedule A attached hereto (the “Marks”), (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

THIS SUPPLEMENTAL GRANT (this “Grant”) is made to secure the satisfactory performance and payment of all the Secured Obligations of each Grantor, as such term is defined in the Security Agreement by and among, among others, the Grantors and the Grantee, dated as September 9, 2016 (as amended, modified, restated and/or supplemented from time to time, the “Security Agreement”). Capitalized terms used but not otherwise defined herein shall have the meaning assigned to them in the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.
