**RELEASE OF TRADEMARK SECURITY INTEREST**

This Release of Trademark Security Interest (this “Release”), dated as of February 26, 2024, is made by and between MGG Investment Group LP, as collateral agent for the benefit of itself and certain lenders (in such capacity, together with its successors and assigns in such capacity, the “Secured Party”), and Asset Marketing Services, LLC, a Delaware limited liability company and its successors and assigns (“Grantor”).

WHEREAS, Grantor entered into a Pledge and Security Agreement, dated as of October 4, 2021 (as amended, restated, supplemented, modified or otherwise changed from time to time, the “Security Agreement”), in favor of the Secured Party;

WHEREAS, pursuant to the Security Agreement and that certain IP Security Agreement - Trademarks, dated as of October 4, 2021, made by Grantor in favor of the Secured Party (the “IP Security Agreement”), Grantor granted to the Secured Party among other collateral, a continuing security interest in all of the Grantor’s right, title and interest in, to and under the trademarks listed on the attached Schedule A (the “Specified Trademarks”), together with, among other things, the good-will of the business symbolized by the Specified Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of actions which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the “Specified Collateral”), to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement);

WHEREAS, evidence of the IP Security Agreement was recorded in the United States Patent and Trademark Office on October 4, 2021, at reel/frame 007441/0748;

WHEREAS, the Secured Party wishes to release its security interest in the Specified Trademarks and the Specified Collateral and retransfer and reassign to Grantor without recourse all of the Secured Party’s right, title and interest in and to the Specified Trademarks and the Specified Collateral.

NOW THEREFORE, the Secured Party hereby releases any security interest it may have in the Specified Trademarks and the Specified Collateral, and reassigns any and all right, title and interest in, to and under the Specified Trademarks and the Specified Collateral that it may have without recourse to Grantor.

For clarity, this Release does not release the Secured Party’s interest in any collateral granted under the Security Agreement and the IP Security Agreement except for the Specified Trademarks and Specified Collateral.

The Secured Party hereby authorizes any Grantor to record and register this Release with the United States Patent and Trademark Office upon the written request by any Grantor


