TRADEMARK ASSIGNMENT AND RELEASE

2. Representations and Warranties. Assignor represents and warrants to Assignee:
 - (a) Assignor has the right, power and authority to enter into this Agreement;
 - (b) Assignor is the exclusive owner of all right, title and interest, including all intellectual property rights, in the Trademark;
 - (c) The Trademark is free of any liens, security interests, encumbrances or licenses;

3. Mutual Releases. Assignee releases Assignor from any and all claims for trademark infringement or any other claims arising out of the use of the Trademark, whether known or unknown, or that may come to light in the future. Assignor releases Assignee from any and all claims that may arise from this Agreement.



