AMENDED AND RESTATED NOTICE OF SECURITY INTEREST
(Trademarks)

Notice is hereby given that **TCI, LLC**, a Wisconsin limited liability company (“Grantor”), with its principal place of business located at W132N10611 Grant Drive, Germantown, Wisconsin 53022, has granted a security interest to **HSBC BANK USA, NATIONAL ASSOCIATION**, a national banking association, as collateral agent (in such capacity, the “Collateral Agent”) for itself and the other Secured Parties (as defined in the IP Security Agreement (defined below)), in and to the trademarks listed on the Schedule attached hereto and the applications, registrations and goodwill, as applicable, associated therewith, pursuant to that certain Amended and Restated Patent and Trademark Security Agreement, dated as of March 1, 2024, by and among **ALLIENT INC.** (f/k/a Allied Motion Technologies Inc.), Grantor, the other grantors party thereto from time to time, and the Collateral Agent, as amended, restated, supplemented or otherwise modified from time to time (the “IP Security Agreement”).

This Notice amends and restates that certain Notice of Security Interest dated January 15, 2019 (the “Original Notice”), given by Grantor in favor of HSBC Bank USA, National Association, as administrative agent, in order to change the capacity of HSBC Bank USA, National Association from “administrative agent” to “collateral agent”. The Original Notice was recorded with the United States Patent and Trademark Office starting at Reel 006631/Frame 0313. No other changes or amendments to the Original Notice are made by this Notice.
