## NUNC PRO TUNC ASSIGNMENT OF TRADEMARKS

This Nunc Pro Tunc Assignment (this "Assignment") is meant to also be considered as confirmatory and corrective and is made, **Executed** and entered into as of the date of last signature below but considered to be **Effective** and confirmed as of the date of the prior Assignments for the marks mentioned and listed therein along with the associated goodwill, all assigned by the same signatories (believed to have happened on or about **November 16, 2016**, for those **trademarks, Registrations and applications for Registration then in existence) and others mentioned hereinbelow on Exhibit A** and is made by and between closely related entities and entities known and referred to as and doing business as indicated but with other and related names, all owned, controlled and operated by Joseph Battat as President and CEO of the stated various entities along with his brother Dany Battat, Vice President at the time of execution and confirmation, for the various entities, with the entities being referred to in various business documents as Maison Joseph Battat Ltd. a limited liability company (sic) of Canada with an address at the time of operation and business of 8440 Darnley Road, Montreal Canada H4T 1M4, yet more correctly and properly a true corporate entity of Canada that should be and should have been referred to as Maison J. Battat Ltd./Ltee. an actual corporation of Canada with the business address of 8440 Darnley Road, Montreal Quebec, Canada H4T 1M4 (**all collectively referred to as Maison J. Battat Ltd./Ltee.**, the use of both Ltd. and Ltee. being a function of the bilingual law of Quebec, Canada (and along with Maison Joseph Battat Ltd./Ltee. (all referred to collectively as the Maison J. Battat Ltd./Ltee. Assignors) and an intermediate receiving party, referred to as 9349-0639 Quebec, Inc. a corporation of Canada, with a business address also of 8440 Darnley Road, Montreal, Canada H4T 1M4 who, by change of name became Maison Battat Inc. (referred to hereinafter as Maison Battat, Inc. Assignee), being a current Canadian Corporation also with an address at 8440 Darnley Road, Montreal Canada H4T 1M4, (Assignors and Assignee may sometimes be referred to herein collectively as the "Parties" and/or each individually as a "Party").

In addition, this Nunc Pro Tunc, confirmatory and corrective Assignment of trademarks listed is meant to confirm and also make of record the transfer of all right, title, and interest, along with the associated goodwill, **of the marks set forth below on Exhibit A**, which were previously owned at the time and transferred from Battat Inc. (a Delaware state entity) to 9349-0639 Quebec Inc. and then from it also to Maison Battat Inc. Assignee and/or from Battat Inc. of Delaware directly to Maison Battat, Inc., as Assignee.

WHEREAS, by Assignments of years ago the Maison J. Battat Ltd./Ltee.. Assignors, and Battat, Inc. and 9349-0639 Quebec, Canada, all assigned certain marks and associated goodwill, as listed on Exhibit A, to Maison Battat, Inc. as a consequence of the change of name of the receiving company;

**WHEREAS the indicated entities of this Nunc Pro Tunc, confirmatory and corrective Assignment** made application for and became the registered owner of the marks listed below and/or attached on Exhibit A and also was the owner of applications for marks as listed on Exhibit A;

**WHEREAS, in certain US Trademark Registrations Maison J. Battat, Inc.** was innocently and incorrectly identified as the owner of the marks and the associated goodwill for the identified Registrations set forth in Exhibit A, and, in fact, the Owner and Assignor of the marks, the associated good will and the identified Registrations was Maison Joesph Battat Ltee./Ltd. as set forth and identified above and the latter was a corporation of Canada,

**WHEREAS, Maison J. Battat Inc. And Maison Joseph Battat Ltd/Ltee. by mesne Assignments of all US and Foreign rights, registrations, applications and associated goodwill in and to the marks identified below in Exhibit A, assigned and transferred the same, including the associated goodwill to 9349-0639 Quebec, Inc. a corporation of Canada, which, by change of name became Maison Battat Inc. still a corporation of Canada;**

And

**WHEREAS, Maison Joseph Battat, Ltd./Ltee. Assignors and Maison Battat Inc. Assignee** wish to confirm those assignments in the past of the Marks, the US Registered Marks, the Registrations as identified, any applications pending in the Assignors' name along with the associated goodwill set forth in Exhibit A so as to confirm current ownership of the same and all of the right, title and interest in, to and under such Marks and the Registrations and listed Applications seeking US Registration along with associated goodwill, all in the entity of **Maison Battat, Inc..**

**NOW, THEREFORE,** for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignors do hereby confirm the sale, assignment, transfer, conveyance, grant, and set over to Maison Battat Inc. Assignee for its own use and enjoyment and for the use and enjoyment of its successors, assigns and other legal representatives forever as fully and entirely as the same would have been held and enjoyed by any of the Maison Joseph Battat, Ltee/Ltd. Assignors, Battat Inc., 9349-0639 Quebec, Inc. as if this Assignment had not been made, Assignors' entire right, title and interest in, to and under the Property, throughout the world in perpetuity, and any renewals, reissues and extensions thereof, together with the goodwill associated with the Marks set forth on Exhibit A and that part of Assignors' business connected with the use thereof and symbolized thereby, and any and all of Assignors' other rights, privileges and priorities provided under state and federal law of the United States, and under the laws of any and all foreign jurisdictions with respect to the Marks, including without limitation, all common law rights and rights under the laws of unfair competition, and any and all rights to all income, royalties, damages, and payments now or hereafter due or payable in respect thereto, and in and to all causes of action (either in law or in equity) and the right to sue, counterclaim and recover for past, present, and/or future infringement, damages, injunctive relief, and/or other monies due to the unauthorized use of the rights currently known to Assignors as of the date of the original Assignments and/or the date hereof or that may become known after the date of this Nunc Pro Tunc,, confirmatory and corrective Assignment to the extent relating to the Marks and the associated goodwill as listed on Exhibit A.

Assignors hereby represent and warrant that they have and had the full right to confirm and to correct and to have conveyed the interest assigned by this Nunc Pro Tunc, Confirmatory and Corrective Assignment, and that they have not conveyed any interest in or right to the listed Trademarks of Exhibit A, nor the associated goodwill to the marks to any third party.

Assignors authorize and request the US Trademark Office to record Assignee, Maison Battat Inc. as the owner of the Marks of Exhibit A, the Registrations and Applications seeking Registration and the Associated Goodwill in the name and as of the property of Assignee Maison Battat Inc. of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.






