FURTHER, Assignor agrees that, upon request and without further compensation, but at no expense to Assignor, it and its legal representative(s) and assigns will do all lawful acts, including the execution of papers and the giving of testimony, that may be necessary or desirable for obtaining, sustaining, reissuing or enforcing any trademark rights based on said Trademarks, and for perfecting, recording or maintaining the title of Assignee, its successors and assigns, to said Trademarks anywhere in the world.

Assignor represents and warrants that Assignor has not granted and will not grant to any other any rights inconsistent with the rights granted herein.

Assignor authorizes and requests authorities of all jurisdictions to issue trademark registrations to Assignee, its successors and assigns, as the assignee of the entire interest in said Trademarks.
