

INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this "Agreement") is entered into as of November 3, 2023 (the "Effective Date"), by and among Mattress Development Company of Delaware, LLC (d/b/a Eclipse International), a Delaware limited liability company having an address at 1375 Jersey Avenue, North Brunswick, New Jersey 08902 ("MDC") and Illinois Sleep Products, Inc., an Illinois corporation having an address at 3535 W. 47th Street, Chicago, Illinois ("ISP", together with MDC, the "Assignors" and each an "Assignor"), on the one hand, and BIA IP Holdco, LLC, a Delaware limited liability company having an address at 730 North Ocean Blvd 1504, Pompano Beach, FL 33062 ("Assignee"), on the other hand. Hereinafter, Assignors and Assignee may be referred to collectively as the "Parties" and, each of them, individually as a "Party." (Capitalized terms used but not defined in this Agreement shall have the respective meanings ascribed to them in the Purchase Agreement (defined below), unless otherwise indicated.)

WHEREAS, that certain Equity Interest Purchase Agreement dated as of October 30, 2023 (as amended, modified or otherwise supplemented from time to time, the "Purchase Agreement"), has been entered into by and between Stuart Carlitz, Steve Sciortino, Jared Carlitz, Phil Carlitz (each of the foregoing being a "Seller"), BIA Minority Shareholder Holdco, LLC, a Delaware limited liability company ("BIA Minority Shareholder Holdco"), Carlitz Enterprises Inc., a New Jersey corporation, BIA West LLC, a California limited liability company, ISP, Whitestone Intermediate Holdings, LLC, a Delaware limited liability company ("Parent"), and Whitestone Home Furnishings, LLC, a Delaware limited liability company ("Buyer");

WHEREAS MDC is a wholly owned subsidiary of Carlitz Enterprises Inc., ISP is a wholly owned subsidiary of Buyer, and Assignee has been formed by, and is wholly owned by, the Sellers;

WHEREAS, in partial payment of the Purchase Price under the Purchase Agreement, Parent has issued to each of the Sellers and BIA Minority Shareholder Holdco those certain Subordinated Promissory Notes dated November 3, 2023 (collectively, the "BIA Notes");

WHEREAS, the Parties have agreed that Assignors shall assign and transfer to Assignee the Intellectual Property listed on Schedule A hereto (collectively, the "Assigned Intellectual Property"), for Assignee to hold until all of the BIA Notes have been paid in full.

NOW, THEREFORE, for good and valuable consideration, including the consideration set forth in this Agreement, the License Agreement (defined below) and the Purchase Agreement, receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties agree as follows.

1. Assignment. Each Assignor hereby assigns, conveys, transfers, and sets over to Assignee the entire right, title, and interest in and to the Assigned Intellectual Property, together with the goodwill associated with and symbolized by the Assigned Intellectual Property, including all statutory, common law rights, and corresponding rights accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world, and all other corresponding rights that are or may be secured under the laws of the United States and any other jurisdiction throughout the world, now or hereafter in

effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by such Assignor if this Agreement had not been made including but not limited to:

- a. All rights to maintain and pursue enforceable rights in the Assigned Intellectual Property, including the right to file applications and otherwise pursue and obtain registration or other protection of the Assigned Intellectual Property, in any jurisdiction, including without limitation, applications for copyrights, trademarks, and domain names, including all rights to claim priority in and to any such applications, including without limitation any extension, nationalization, counterpart, or renewal thereof;
- b. All other rights under all international conventions for the protection of intellectual and industrial property with respect to the Assigned Intellectual Property; and
- c. All rights to sue for, and recover for, infringements of, or liabilities for, the Assigned Intellectual Property, including those infringements occurring and liabilities accruing prior to execution of this Agreement.
- 2. Excluded Assets. The assignment set forth in Section 1 above shall not apply to any intent-to-use (or similar) trademark application unless and until a "Statement of Use", "Amendment to Allege Use" or similar filing has been filed with, and accepted by, the USPTO pursuant to Section 1(c) or Section 1(d) of the Lanham Act (15 U.S.C. §1051, et seq.).
- 3. BIA Notes. For the avoidance of doubt, under no circumstances shall the principal and/or accrued interest of the BIA Notes be reduced by virtue of this Agreement, and the Assigned Intellectual Property shall not be deemed to be collateral for the BIA Notes by any Party to this Agreement or any third party.
- 4. Existing License Obligations. For the avoidance of doubt, the assignment of the Assigned Intellectual Property from Assignors to Assignee under this Agreement shall be subject to the license-back to Assignors (or any designated Affiliates of an Assignor) under the License Agreement (defined below) and any and all licenses or other rights granted to any third party in respect of the Assigned Intellectual Property under or pursuant to any license or other agreement in effect as of the Effective Date pursuant to which an Assignor or its Affiliate, as applicable, grants any right, title or interest in, to or under the Assigned Intellectual Property to any third party.
- 5. License Agreement. Concurrent with the effectiveness of this Agreement, Assignee and Assignors, or any designated Affiliate of an Assignor, shall enter into that certain Intellectual Property License Agreement (the "License Agreement"), which shall become effective immediately upon the Effective Date.
- 6. Recordation of Assignment. This Assignment has been executed and delivered by Assignors for the purpose of recording the assignment herein with the appropriate government entity. Each Assignor hereby authorizes the United States Patent and Trademark Office and any other patent and trademark office or similar or comparable agency, office, register or registrar in any country or jurisdiction to record Assignee, and its successors and assigns, as the owner of the

Assigned Intellectual Property in accordance with the terms of this instrument, and to issue any such registration, certificate or document in such country or jurisdiction in the name and for the benefit of Assignee, its successors and assigns. Assignee and its successors and/or assigns shall bear and be responsible for (and, to the extent incurred by an Assignor or its Affiliates, shall reimburse such Assignor for) any and all costs incurred to perfect, record, protect or more fully evidence the Assignee's and its successors' and/or assigns' respective right, title and interest in and to the Assigned Intellectual Property, including, without limitation, its recordation in the United States Patent and Trademark Office and all applicable U.S. and foreign local, state and national intellectual property offices.

- 7. Further Assurances. Assignors shall take all further actions, and provide to Assignee, and to Assignee's successors, assigns, or other legal representatives, all such cooperation and assistance reasonably requested by Assignee to more fully and effectively effectuate the purposes of this Agreement, including the execution of any further documents that may be necessary in order to effectuate this Agreement, at Assignee's expense.
- 8. Domain Name Transfer. To effectuate the assignment of the domain name(s) included in the Assigned Intellectual Property, each Assignor agrees to take any and all actions that are necessary to perfect the assignment of the domain names and/or to transfer control of the domain names to Assignee (subject to such Assignor's rights under the License Agreement). These actions may include, but are not limited to, promptly (i) unlocking the domain names and providing the authorization code for the domain names to Assignee; (ii) executing and/or completing such other additional documents or forms as are delivered to such Assignor by Assignee or the applicable registrar; and (iii) taking the necessary steps required by the applicable registrar to transfer the domain names to Assignee. Each Assignor agrees to retain the registration for the domain names until they are effectively transferred to Assignee by the domain name registrar. Each Assignor further hereby authorizes the current registrar of each domain name to transfer the ownership and control of such domain name to Assignee.
- 9. Terms of the Purchase Agreement. The Parties hereto acknowledge and agree that the representations, warranties, covenants, agreements and indemnities contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of a conflict or an apparent conflict between the provisions of this Agreement and the provisions of the Purchase Agreement, the provisions of the Purchase Agreement shall control.

10. Miscellaneous.

(a) Severability. The provisions of this Agreement shall be severable, and if any provision of this Agreement shall be held or declared to be illegal, invalid, or unenforceable in any jurisdiction, such illegality, invalidity or unenforceability shall not affect any other provision hereof or the interpretation and effect of the Agreement as to any other jurisdiction, and the remainder of Agreement, disregarding such illegal, invalid or unenforceable provision shall continue in full force and effect as though such illegal, invalid, or unenforceable provision had not been contained herein.

- (b) Governing Law. This Agreement shall be governed by and construed in accordance with the internal laws of the State of Delaware without giving effect to any choice or conflict of law provision or rule (whether of the State of Illinois or any other jurisdiction).
- (c) No Modifications. This Agreement may not be released, discharged, abandoned, amended, changed or modified in any manner except in an instrument signed by each of the parties hereto.
- (d) Authority. The persons signing below on behalf of Assignors and Assignee hereby personally warrant and guaranty their authority to bind Assignors and Assignee to this Agreement. The parties represent and warrant that each has the authority to undertake the obligations set forth in this Agreement without breaching or violating any contractual or statutory obligation owed to another.
- (e) Counterparts. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Counterparts may be delivered via electronic mail (including pdf or any electronic signature complying with the ESIGN Act of 2000, e.g. www.docusign.com) or other transmission method, and any counterpart so delivered shall be deemed to have been duly and validly delivered and be valid and effective for all purposes.
