The Assignor shall execute and deliver, at the reasonable request of Assignee, such further instruments of conveyance, grant, assignment, transfer, and delivery, and take such other actions, as Assignee reasonably requests to more effectively consummate the transaction contemplated by this Agreement.

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States Patent and Trademark Office to record the assignment of the Trademarks of Assignor to, and for the sole use and benefit of, Assignee, its successors and assigns.


