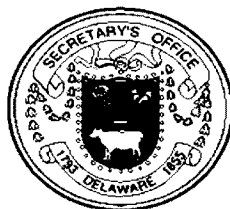

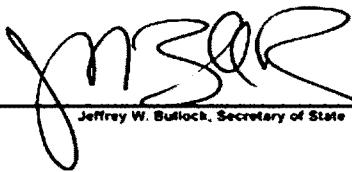

Bays Bakery, Inc., an Illinois corporation ("Terminating Corporation") and Bimbo Bakehouse LLC, a Delaware limited liability company ("Surviving LLC"), do hereby certify to the following facts relating to the merger ("Merger") of the Terminating Corporation with and into the Surviving LLC.

1. The names and states of formation or incorporation of the constituent legal entities of the Merger are Bays Bakery, Inc., which was organized pursuant to the Illinois Business Corporation Act ("BCA"), and Bimbo Bakehouse LLC, which was organized pursuant to the Delaware Limited Liability Company Act ("DLLCA").
