## **BACKGROUND**

- (A)** The Assignor is the proprietor of United States Trade Mark Application No. 98457383 SUNUV in Class 3 (the Trade Mark)
  
- (B)** The Assignor has agreed to assign the Trade Mark to the Assignee on the terms set out in this agreement.

## **1. ASSIGNMENT**

All payments made by the Assignee under this agreement are exclusive of VAT. If any such payment constitutes the whole or any part of the consideration for a taxable or deemed taxable supply by the Assignor, the Assignee shall increase that payment by an amount equal to the VAT which is chargeable in respect of the taxable or deemed taxable supply,

The Assignor shall at the direction and expense of the Assignee promptly execute and deliver such documents and perform such acts as may reasonably be required for the purpose of giving full effect to this agreement.

**4. THIRD PARTIES**

This agreement does not create any rights enforceable by any person not a party to it.

This agreement and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the law of England and Wales. Each party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with this agreement or its subject matter or formation.
