### TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This Termination and Release of Trademark Security Agreement (this "Release Agreement"), dated as of March 19, 2024, is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, in its capacity as administrative agent for each member of the Lender Group and the Bank Product Providers (in such capacity, together with its successors and assigns in such capacity, "Agent") in favor of SALARY.COM, LLC, a Delaware limited liability company ("Grantor").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:

- 1. Release and Assignment. Agent, on behalf of itself and each member of the Lender Group and the Bank Product Providers, hereby discharges, terminates and releases the Security Interest in all of the Trademark Collateral, hereby assigns and transfers to the Grantor, without warranty or recourse, all of Agent's right, title and interest in and to the Trademark Collateral and the related registrations and goodwill, and hereby terminates the Trademark Security Agreement, effective as of the date set forth above.
- 2. <u>Further Assurances</u>. Agent hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or required in order to more fully and effectively carry out the purposes of this Release Agreement, in each case at the Grantor's sole cost and expense.
