**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this “Release”), dated as of March 27, 2024, is made by Antares Capital LP, as collateral agent for the Secured Parties (together with its successors and permitted assigns, the “Collateral Agent”) in favor of Creative Group, Inc., a Wisconsin corporation, Direct Travel, Inc., a Delaware corporation, VTS Travel Enterprises, Inc., a New York corporation, and Ambassador Travel, LLC, an Indiana limited liability company (collectively, the “Grantors”), as follows:

WITNESSETH:

WHEREAS, pursuant to that certain Guaranty and Security Agreement dated as of December 1, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Guaranty and Security Agreement”), among the Grantors and the other parties party thereto in favor of the Collateral Agent, and those certain agreements described on Annex I attached hereto (the “IP Security Agreements”), the Grantors mortgaged, pledged and hypothecated to the Collateral Agent for the benefit of the Secured Parties, and granted to the Collateral Agent for the benefit of the Secured Parties a Lien on and security interest in, all of each Grantors right title and interest in, to and under certain collateral in favor of the Collateral Agent, including the IP Collateral (as hereinafter defined); and

WHEREAS, the Collateral Agent now desires to terminate and release each IP Security Agreement and the entirety of its security interests granted therein, including in the IP Collateral described on Annex I attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Collateral Agent hereby agrees as follows:

1. Definitions. The term “IP Collateral”, as used herein, shall mean all of the Grantors’ right, title or interest in, or to any and all of the trademarks and copyrights listed on Annex I attached hereto. Capitalized terms not defined herein have the meanings set forth in the Guaranty and Security Agreement or IP Security Agreements, as applicable.

2. Release of Security Interest. The Collateral Agent, without recourse, representation or warranty and at the Grantors’ sole cost and expense, hereby terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of the Grantors, and their successors and assigns, its security interest in and to the IP Collateral, the IP Security Agreements and any and all right, title and interest of the Collateral Agent in, to and under the IP Security Agreements including the IP Collateral shall hereby be terminated, cancelled, released, relinquished and discharged. The Collateral Agent hereby authorizes the Grantors and their successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office (“USPTO”) and the United States Copyright Office (“USCO”), at the sole expense of the Grantors, to evidence and effectuate the release and termination of the Collateral Agent’s security interest in the IP Collateral.


