RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Amware Fulfillment LLC, a Delaware limited liability company ("**Parent**"), in connection with (a) the Loan and Security Agreement, dated as of May 22, 2014 (the "**Loan and Security Agreement**"), by and among Parent, Amware Fulfillment of Arizona, LLC, a Georgia limited liability company, Amware Fulfillment of Connecticut, LLC, a Georgia limited liability company, Amware Fulfillment of Georgia, LLC, a Georgia limited liability company, Amware Fulfillment of Pennsylvania, LLC, a Georgia limited liability company, NKM Warehousing, LLC, a Georgia limited liability company, M. J. 
