NOTICE OF GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS

The rights and remedies of the Grantee, with respect to the security interest granted herein are as set forth in the Loan Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provision of this Grant is deemed to conflict with the Loan Agreement, the provisions of the Loan Agreement shall govern.


