**EXECUTION VERSION**

TRADEMARK SECURITY AGREEMENT dated as of March 28, 2024 (this “Agreement”), among CGI WINDOWS AND DOORS, LLC, ECO WINDOW SYSTEMS, LLC, MDM UTAH, LLC, PGT INDUSTRIES, LLC, PGT INNOVATIONS, LLC, WESTERN WINDOW HOLDING LLC, WINDOOR, LLC and WWS ACQUISITION, LLC (each a “Grantor”) and U.S. Bank Trust Company, National Association, as Notes Collateral Agent (in such capacity, the “Notes Collateral Agent”).

Reference is made to the Indenture dated as of March 28, 2024 (as amended, supplemented or otherwise modified from time to time, the “Indenture”), among MITER Brands Acquisition Holdco, Inc., a Delaware corporation, and MIWD Borrower, LLC, a Delaware limited liability company (together, the “Issuers”), the Grantors party thereto and U.S. Bank Trust Company, National Association, as Trustee and Notes Collateral Agent and (b) the Notes Pledge and Security Agreement dated as of March 28, 2024 (the “Notes Pledge and Security Agreement”), among the Issuers, MIWD Holdco II LLC, a Delaware limited liability company, and MIWD Finance Corporation, a Delaware corporation (together, the “Parents”), the various other Grantors party thereto and the Notes Collateral Agent. Each Grantor is an Affiliate of the Issuers and is willing to execute and deliver this Agreement as consideration for Notes previously issued. Accordingly, the parties hereto agree as follows:

SECTION 1. Terms. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Notes Pledge and Security Agreement or the Indenture, as applicable. The rules of construction specified in Section 1.01(b) of the Notes Pledge and Security Agreement also apply to this Agreement.

SECTION 2. Grant of Security Interest. As security for the payment or performance, as the case may be, in full of the Secured Notes Obligations, each Grantor hereby grants to the Notes Collateral Agent, its successors and assigns, for the benefit of the Secured Notes Secured Parties, a security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in, to and under any Trademarks now owned or at any time hereafter acquired by such Grantor, including those U.S. Trademark registrations and applications listed on Schedule I (the “Trademark Collateral”).

SECTION 3. Notes Pledge and Security Agreement. The Security Interest granted to the Notes Collateral Agent herein is granted in furtherance, and not in limitation, of the security interests granted to the Notes Collateral Agent pursuant to the Notes Pledge and Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Notes Collateral Agent with respect to the Trademark Collateral are more fully set forth in the Notes Pledge and Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Notes Pledge and Security Agreement, the terms of the Notes Pledge and Security Agreement shall govern.


SECTION 4. Counterparts. This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original but all of which when taken together shall constitute a single contract. Delivery of an executed signature page to this Agreement by facsimile or other electronic transmission shall be effective as delivery of a manually signed counterpart of this Agreement.

SECTION 5. Governing Law. This Agreement shall be construed in accordance with and governed by the law of the State of New York.


