TERMINATION AND RELEASE OF  
SECURITY AGREEMENT FOR INTELLECTUAL PROPERTY, SUPPLEMENT NO. 4

This TERMINATION AND RELEASE OF SECURITY AGREEMENT FOR INTELLECTUAL PROPERTY, SUPPLEMENT NO. 4 (this “IP Release”) is made as of December 21, 2023, by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, in its capacity as collateral agent (the “Collateral Agent”), in favor of **QUOIZEL, LLC**, a New York limited liability company (the “Grantor”).

WHEREAS, pursuant to that certain ABL Security Agreement, dated as of April 26, 2017 (the “Security Agreement”; initially capitalized terms used herein without definition shall have the meaning set forth in the Security Agreement), the Grantor granted and pledged to the Collateral Agent a security interest (the “Security Interest”) in the Grantor’s right, title and interest in, to certain ABL Collateral of the Grantor;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered to the Collateral Agent a Security Agreement for Intellectual Property, Supplement No. 4, dated as of January 9, 2019 (the “IP Supplement”), which was recorded (i) with the Patent Division of the United States Patent and Trademark Office (the “USPTO”) on February 20, 2019 at Reel 048383, Frame 0225, (ii) with the Trademark Division of the USPTO on February 20, 2019 at Reel 6574, Frame 0920 and (iii) with the United States Copyright Office (the “USCO”) on February 21, 2019 at Volume 9971, Doc. No. 860; and

WHEREAS, the Grantor has requested that the Collateral Agent execute this IP Release in order to terminate and release the Collateral Agent’s Security Interest in the ABL Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged:

1. Release of Lien. The Collateral Agent hereby terminates the IP Supplement and hereby terminates, cancels and releases the Security Interest in the ABL Collateral, including (a) those Patents, registrations, and applications referred to on Exhibit A attached hereto, (b) all Trademark registrations and applications referred to on Exhibit B attached hereto, and (c) all Copyrights referred to on Exhibit C attached hereto.

2. Authorization to Record. The Collateral Agent authorizes and requests that the USPTO, USCO, and any applicable government officer record this IP Release.

3. Governing Law. THIS IP RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES THEREOF THAT WOULD RESULT IN THE APPLICATION OF ANY LAW OTHER THAN THE LAW OF THE STATE OF NEW YORK.

4. Counterparts. This IP Release may be executed in any number of separate counterparts, each of which shall, collectively and separately, constitute one agreement.
