DEED OF ASSIGNMENT (Trademarks)

This Deed of Assignment (“**Trademark Assignment**”), effective as of 14 November, 2023, (“**Effective Date**”), is by and between Alkermes, Inc., a Pennsylvania corporation whose principal address is 900 Winter Street, Waltham, Massachusetts 02451 (“**Assignor**”) and Alkermes plc, a public limited company organized under the laws of Ireland, with registered number 498284 and whose registered address is Connaught House, 1 Burlington Road, Dublin 4, Ireland and (“**Assignee**”). Assignor and Assignee are sometimes referred to herein individually as a “**Party**” and collectively as the “**Parties.**”

WHEREAS, Assignor is the owner of the trademarks for which the trademark applications set forth on Schedule A have been filed (collectively, the “**Assigned Trademarks**”);

WHEREAS, Assignee has agreed to purchase from Assignor and Assignor has agreed to sell, convey, assign, transfer and deliver to Assignee all of Assignor’s rights, title and interest in and to the Assigned Trademarks, together with any goodwill of the business associated with and symbolized by the Assigned Trademarks.

NOW, THEREFORE, in consideration of the foregoing and the mutual representations, warranties, covenants and agreements contained herein, as well as other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Parties agree as follows:

1. **Conveyance and Acceptance of Assigned Trademarks.** Assignor hereby sells, conveys, assigns, transfers and delivers to Assignee (and to Assignee’s successors and permitted assigns), all of its right, title and interest in and to the Assigned Trademarks, including all common law rights therein, and all trademark registrations and registration applications relating to the Assigned Trademarks and the right to claim priority to same under the Paris Convention or any other national or international law, together with all proceeds, benefits, privileges, causes of action, and remedies relating to or arising from the Assigned Trademarks, all rights to bring oppose, defend and appeal (and/or to obtain relief in respect of) any proceedings, actions or claims, whether at law or in equity, for infringement or other violation of or any other cause of action arising from ownership of, any of the Assigned Trademarks against any third party, all rights to recover (and

retain) damages, profits and other remedies in respect of any past or future infringement or other violation of the Assigned Trademarks, and all goodwill of the business associated with and symbolized by the Assigned Trademarks, and Assignee hereby accepts such sale, conveyance, assignment, transfer and delivery.

2. **Further Assurances.** Assignor agrees, at Assignee's expense, to take such further action and to execute and deliver, or cause to be executed and delivered, such further instruments and take such other actions as may be necessary or desirable to carry out the transactions contemplated by this Trademark Assignment, including signing all papers and documents, taking all lawful oaths and doing all acts necessary or required to be done to vest, perfect or confirm of record or otherwise in Assignee any and all right, title and interest in, to and under any of the Assigned Trademarks.

3. **Counterparts.** This Trademark Assignment may be executed in multiple counterparts, each of which shall be deemed to be an original but all of which shall constitute one and the same agreement. Transmission of an executed counterpart of this Trademark Assignment (but for the avoidance of doubt not just a signature page) by email (in PDF, JPEG, digital image or other agreed format) shall take effect as delivery of an executed counterpart of this Assignment.

4. **Governing law and jurisdiction.** The validity, construction, and performance of this Assignment shall be governed by the laws of Ireland and shall be subject to the exclusive jurisdiction of the courts of Ireland to which the Parties submit.

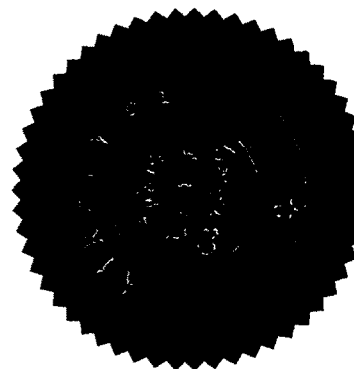
