**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of April 1, 2024 (“**Release**”), is made by Bank of America, N.A., as administrative agent (“**Agent**”) in favor of Spartan Energy Partners LP, a Delaware limited partnership (“**Grantor**”).

WHEREAS, reference is made to that certain Loan, Security and Guaranty Agreement dated as of January 29, 2021 (as amended, supplemented or otherwise modified from time to time, the “**Loan Agreement**”), by and among the Obligors party thereto and Agent;

WHEREAS, pursuant to the Loan Agreement, Grantor executed and delivered to Agent, for the benefit of the Secured Parties, the Trademark Security Agreement dated as of January 29, 2021 (“**IP Security Agreement**”); and

WHEREAS, the IP Security Agreement was recorded at the United States Patent and Trademark Office (“**USPTO**”) on March 17, 2021 at Reel 7236 Frame 0315.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent, on behalf of the Secured Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Loan Agreement or IP Security Agreement.

SECTION 2. Termination and Release. Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates the IP Security Agreement and terminates, cancels, discharges, reassigns and releases the security interest it has against the Trademark Collateral, including, but not limited to, the Trademark, Trademark licenses and Trademark applications listed on **Schedule A** attached hereto;

(b) if and to the extent the Agent has acquired any right, title or interest in, to or under any Trademark Collateral, assigns, transfers, conveys and delivers such right, title or interest to the Grantor; and

(c) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
