**PLAN OF CONVERSION
OF
ALPHA SOURCE INC.**

The terms and conditions of the conversion of Alpha Source Inc., a Wisconsin corporation, into Alpha Source LLC, a Wisconsin limited liability company, (the "Conversion") are as follows:

**ARTICLE I
CONVERSION; EFFECTIVE TIME**

At the Effective Time of the Conversion (as hereinafter defined), Alpha Source Inc. shall be converted into Alpha Source LLC, a Wisconsin limited liability company, which shall be the converted business entity (the "Converted Entity"). The effective time of the Conversion shall be upon filing of the Articles of Conversion with the Wisconsin Department of Financial Institutions ("Effective Time of the Conversion").

**ARTICLE II
CONVERSION OF STOCK**

At the Effective Time of the Conversion, all of the issued and outstanding shares of stock of Alpha Source Inc. shall be converted into a single undivided membership interest in the Converted Entity.

**ARTICLE III
ARTICLES OF ORGANIZATION AND OPERATING AGREEMENT**

A copy of the Articles of Organization of the Converted Entity is attached hereto as Annex I. Immediately following the Effective Time of the Conversion, the members of the Converted Entity shall adopt an Operating Agreement to govern the operations of the Converted Entity.

**ARTICLE IV
EFFECT OF CONVERSION**

The effect of the Conversion shall be as provided in Section 180.1161(4) of the Wisconsin Business Corporation Law and Section 183.1207(4) of the Wisconsin Limited Liability Company Act.
