**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST
(TRADEMARKS)**

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST (TRADEMARKS) (this "Termination"), is dated as of March 27 , 2024, and made by DEERFIELD MGMT, L.P. (the "Grantee"), to ESSENCE GROUP HOLDINGS CORPORATION a Delaware corporation ("Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of April 19, 2016, made by Grantor in favor of Grantee (the "Trademark Security Agreement"), a security interest was granted by Grantor to Grantee in certain collateral, including the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent Trademark Office on May 13, 2016 at Reel/Frame 5792/0697;

WHEREAS, Grantee now desires to terminate the Trademark Security Agreement and terminate, release and discharge its security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. Capitalized terms used, but not defined, herein shall have the meaning given such terms in the Trademark Security Agreement.
2. Release of Security Interest. Grantee hereby terminates the Trademark Security Agreement and terminates, releases and discharges its security interest in the Trademark Collateral, including but not limited to all intellectual property listed on Exhibit A hereto, and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark Collateral.
3. Recordation. The parties hereto hereby further authorize and consent that this Terminations may be recorded and indexed by the Commissioner of Patents and Trademarks of the United States Patent and Trademark Office.
