RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY (this “Release”) is made as of this 5th day of April 2024, by BRIGHTWOOD LOAN SERVICES LLC, as administrative agent (the “Second Lien Agent”), in favor of HYLAN DATACOM & ELECTRICAL LLC, a Delaware limited liability company (the “Grantor”).

WHEREAS, Grantor entered into that certain Intellectual Property Security Agreement, dated as of March 11, 2022 (the “Second Lien IP Security Agreement”; capitalized terms used herein but not otherwise defined herein shall have the meanings assigned to such terms in the Second Lien IP Security Agreement) with Second Lien Agent, notice of which was recorded on March 14, 2022 at the United States Patent and Trademark Office (the “USPTO”) at Reel 007658, Frame 0741;

WHEREAS, Grantor granted Second Lien Agent, under the terms of the Second Lien IP Security Agreement, a continuing security interest (the “Security Interest”) in favor of Second Lien Agent, in and to its Patents, Copyrights, Trademarks and IP Licenses constituting Collateral, including without limitation the Trademarks listed on Schedule A attached hereto (the “Second Lien Intellectual Property Collateral”); and

WHEREAS, Second Lien Agent has agreed to terminate and release its Security Interest in all such Second Lien Intellectual Property Collateral as herein provided.

NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Second Lien Agent, on behalf of itself and the other Secured Parties, hereby (a) releases all security interests, lien and mortgage, and right of setoff granted by Grantor in favor of Second Lien Agent in, to and against the Second Lien Intellectual Property Collateral, including the Trademarks listed on Schedule A attached hereto and (b) reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Second Lien Agent, all of Second Lien Agent’s right, title and interest (if any) in and to the Second Lien Intellectual Property Collateral.

Second Lien Agent authorizes and requests that the USPTO and any applicable governmental officer record this Release.



This Release and the rights and obligations of the parties hereto shall be governed by, and construed in accordance with, the laws of the State of New York.


