## RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (this "Release") is made effective as of April 5, 2024, by and from AVENUE VENTURE OPPORTUNITIES FUND, L.P. ("Avenue", as administrative agent and collateral agent (in such capacity, "Agent"), on behalf of Avenue and AVENUE VENTURE OPPORTUNITIES FUND II, L.P. ("Avenue 2" and together with Avenue, in its capacity as a secured party, collectively, "Secured Parties", and each a "Secured Party"), to PROUD SOURCE WATER, LLC, a Delaware public benefit limited liability company and SOURCE GLOBAL, PBC, a Delaware public benefit corporation (each a "Grantor" and collectively the "Grantors"), as follows:

WHEREAS, on February 17, 2023, Secured Parties and Grantors entered into that certain Intellectual Property Security Agreement (as amended, restated or supplemented from time to time, the "IP Security Agreement") with respect to certain patents and trademarks;

WHEREAS, the IP Security Agreement was recorded by the Patent Division of the the United States Patent and Trademark Office on March 3, 2023 at Reel 062868, Frame 0396;

WHEREAS, the IP Security Agreement was recorded by the Trademark Division of the the United States Patent and Trademark Office on March 21, 2023, at Reel 8010, Frame 0983;

WHEREAS, all amounts owing and due under that certain loan agreement among Grantors and Secured Parties were repaid, and all security interests granted to Secured Parties under the IP Security Agreement have been released and terminated; and

WHEREAS, Secured Parties wishes to further evidence its release of its interest in the Collateral (as defined in the IP Security Agreement) including, without limitation, the patents and trademarks listed on Appendix 1, and retransfer and reassign to Grantors all of Secured Parties' right, title and interest in and to such Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Definitions. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the IP Security Agreement.

2. Release of Security Interest. Secured Parties hereby release, terminate, cancel, relinquish and discharge any security interest they may have under the IP Security Agreement, including but not limited to any security interest in and to, and any right of set-off against, Grantors' right, title and interest in, to and under the Collateral, including but not limited to those items listed on Appendix 1, including any goodwill of the business symbolized by the foregoing and all rights to sue for past, present, and future infringements thereof, and retransfers and reassigns, without warranty or recourse, any and all right, title and interest Secured Parties may have in and to the foregoing.

3. Delivery by Facsimile. Delivery of an executed signature page to this Release by electronic (including .pdf file) transmission shall be as effective as delivery of a signed counterpart of this Release.
