**UNITED STATES TRADEMARK SECURITY AGREEMENT**

This UNITED STATES TRADEMARK SECURITY AGREEMENT (this “**Agreement**”) dated as of April 1, 2024 is made by SINGER EQUIPMENT COMPANY, INC., a Delaware corporation with an address of 150 South Twin Valley Road, Elverson, Pennsylvania 19520 (together with its successors and assigns, “**Grantor**”), in favor of MANUFACTURERS AND TRADERS TRUST COMPANY, a New York banking corporation with an address of One M&T Plaza, Buffalo, New York 14203 in its capacity as Administrative Agent (together with its successors and assigns, in such capacity, “**Administrative Agent**”).

WHEREAS, this Agreement has been executed by Grantor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office;

WHEREAS, Grantor owns certain trademarks, including the applications and registrations thereof, and the trade name and common law rights thereto, together with the goodwill of the business connected with the use of and symbolized by the trademarks, including that portion of the business to which the trademarks pertain, and all proceeds thereof, including, without limitation, any and all past, present and future causes of action which may exist by reason of infringement thereof, set forth on Schedule A hereto (collectively, the “**Trademarks**”); and

WHEREAS, Grantor, Administrative Agent and the other parties thereto executed that certain Security Agreement dated as of June 24, 2020 (the “**Security Agreement**”), pursuant to which the Grantor agreed to grant and granted in favor of Administrative Agent a security interest in certain of its assets to secure obligations owing to Administrative Agent.

NOW, THEREFORE, for good and valuable consideration, Grantor hereby pledges and grants to Administrative Agent (and confirms and ratifies all other pledges and grants heretofore

made to Administrative Agent) a security interest and lien in and to the Trademarks to secure the Secured Obligations (as defined in the Security Agreement), subject to the terms and conditions of the Security Agreement.
