## SERVICE MARKS TRANSFER AGREEMENT

This Agreement ("Agreement") is entered into on this 2<sup>ND</sup> day of January, 2024, by and between DPG Partners LLC, a Texas limited liability company ("Transferor"), and M & T Partners Holdings LLC, a Texas limited liability company ("Transferee"). WHEREAS, Transferee desires to acquire all rights, title, and interest in and to the Service Marks;



- Effective Date.** The effective date of this transfer shall be January 2, 2024.
- Representations and Warranties.** Transferor represents and warrants that it is the sole and exclusive owner of the Service Marks, that the Service Marks are free and clear of any liens or encumbrances, and that Transferor has the full right and authority to transfer the Service Marks to Transferee.
- Further Assurances.** Transferor agrees to execute and deliver any additional documents and take any further actions that may be necessary or desirable to effectuate the transfer of the Service Marks to Transferee.
- Governing Law.** This Agreement shall be governed by and construed in accordance with the laws of the United States Patent and Trademark Office, United States of America.


