**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”) is made as of March 26, 2024, **GOLDMAN SACHS BANK USA**, in its capacity as collateral agent under the security agreements referred to below (“**Collateral Agent**”), in favor of **MOVEMENT HOLDINGS, LLC** (F/K/A EL CAP HOLDINGS, LLC), a Delaware limited liability company, and **MOVEMENT SUMMIT GROUP, LLC**, a Texas limited liability company (each individually, a “**Grantor**” and, collectively, “**Grantors**”).

**WHEREAS**, reference is hereby made to (a) that certain Pledge and Security Agreement (as supplemented or otherwise modified from time to time), dated as of November 5, 2019, executed by Grantors in favor of Collateral Agent, and (b) that certain Trademark Security Agreement (as supplemented or otherwise modified from time to time), dated as of December 29, 2023, executed by Grantors in favor of Collateral Agent, and recorded in the records of the United States Patent and Trademark Office on December 29, 2023 at Reel/Frame 8303/0807; and

**WHEREAS**, pursuant to the above-referenced security agreements, Grantors granted to Collateral Agent a security interest in and continuing lien on all of Grantor’s right, title and interest in, to and under those trademarks set forth on Schedule A hereto (collectively, the “**Trademark Collateral**”).

**FOR GOOD AND VALUABLE CONSIDERATION**, the receipt and adequacy of which are hereby acknowledged, Collateral Agent hereby:

(i) terminates and releases all security interests and continuing liens granted by Grantors in favor of Collateral Agent in (a) all of its Trademarks (as defined in the Pledge and Security Agreement), including the U.S registrations and applications for registration referred to on Schedule A hereto; (b) all extensions or renewals of any of the foregoing; (c) all of the goodwill of the business connected with the use of, and symbolized by the foregoing; (d) the right to sue for past, present and future infringement or dilution of any of the foregoing or for any injury to goodwill; and (e) all Proceeds of the foregoing, including licenses, royalties, income, payments, claims, damages and proceeds of suit;

(ii) assigns, transfers and delivers to Grantors all of its right, title and interest in and to the Trademark Collateral to the extent that any such right, title and interest exists as of the date hereof;

(iii) authorizes Grantors or its designee to make filings with the United States Patent and Trademark Office and to take further actions necessary to evidence the release and termination of Collateral Agent’s security interests in and liens on the Trademark Collateral; and

(iv) authorizes the governing body of the United States Patent and Trademark Office to record this Release.
