TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of April 15, 2024, by ROYAL BANK OF CANADA, an Alberta bank (in such capacity, together with its successors and assigns, “Opco Collateral Agent”) in favor of WAWONA PACKING CO. LLC, a California limited liability company with an address at 7700 N Palm Ave, Suite 206, Fresno, CA 93711 and GERAWAN FARMING LLC, a California limited liability company with an address at 7700 N Palm Ave, Suite 206, Fresno, CA 93711 (each, a “Grantor” and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, each Grantor entered into a certain Trademark Security Agreement dated April 3, 2023 (the “Trademark Security Agreement”) with the Opco Collateral Agent, notice of which was recorded on April 3, 2023 at the United States Patent and Trademark Office at Reel 8031, Frame 0021.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, each Grantor granted the Opco Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Opco Collateral Agent, in all of each such Grantor’s right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks listed in Schedule A.

WHEREAS, the Opco Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Opco Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby terminates the Trademark Security Agreement and cancels, releases, terminates and discharges (in each case, without any recourse to, or any representation or warranty by, the Opco Collateral Agent) any and all of its right, title, and interest in and to the Trademark Collateral of the Grantors, and assigns, transfers and conveys to Grantors (in each case, without any recourse to, or any representation or warranty by, the Opco Collateral Agent) the Security Interest in such intellectual property.
