## TRADEMARK ASSIGNMENT

This partial Trademark Assignment is made this 1<sup>st</sup> day of August, 2023 (the “Effective Date”) by and between The Hymed Group Corporation, a Delaware corporation having a mailing address of 1817 Apple Tree Lane, Bethlehem, Pennsylvania 18015 (the “Assignor”) and Sanara MedTech Applied Technologies, LLC, a Texas limited liability company having a business address at 1200 Summit Avenue, Fort Worth, Texas 76102 (the “Assignee”).

Pursuant to an Asset Purchase Agreement executed by and between Assignor and Assignee on August 1, 2023, Assignee purchased from Assignor the assets of Assignor’s on-going and existing collagen human wound care business, including the right, title, and interest in and to U.S. Trademark Registration No. 5,607,820 issued on November 13, 2018 and the trademark Collamin® (collectively, the “Mark”) as used in connection with goods related to the purchased collagen human wound care business, together with the goodwill symbolized thereby.

This Trademark Assignment is being executed to memorialize in writing the partial assignment of the Mark to Assignee as it pertains to goods related to the purchased collagen human wound care business. Assignor retains all right, title and interest in and to the Mark for all uses in its on-going and existing business other than in connection with collagen human wound care, including all other human uses.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, transfers, conveys and assigns in part to Assignee, its successors and assigns, the right, title and interest in and to the Mark only to the extent the Mark pertains to Assignee’s purchase of Assignor’s on-going and existing collagen human wound care business, together with the goodwill symbolized by said Mark as it relates to said collagen human wound care business, and with the right to recover damages and profits and all other remedies for all past and future infringements thereof related to use of the Mark in connection with said collagen human wound care business. All right, title, and interest in and to the Mark as it relates to Assignor’s on-going and existing business other than said collagen human wound care business sold to Assignee, including all other human uses, together with the separate and distinct goodwill associated therewith, is expressly retained by Assignor.

A request to divide U.S. Trademark Registration No. 5,607,820 into separate registrations owned by Assignor and Assignee is being concurrently filed with the Commissioner for Trademarks to ensure USPTO records accurately reflect current ownership.

The description of goods in U.S. Trademark Registration No. 5,607,820 “Pharmaceutical preparations for wounds; Chondroprotective agents, namely, pharmaceutical preparations that protect and promote the growth of cellular structure and cartilage in soft and hard tissue” shall


be amended in the request to divide to reflect the partial assignment of the Mark, as follows:

*Assignor: (Int'l Class 05) - Pharmaceutical preparations for other than human wounds; Chondroprotective agents, namely, pharmaceutical preparations that protect and promote the growth of cellular structure and cartilage in soft and hard tissue.*

*Assignee: (Int'l Class 05) - Pharmaceutical preparations, namely, collagen for human wounds.*
