RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS

This RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of April 12, 2024, is made by ANTARES CAPITAL LP, as Collateral Agent for the Secured Parties (in such capacity, the “Agent”) in favor of LUCITY, INC. and TELLUS SAFETY SOLUTIONS, LLC (each, a “Grantor” and together, the “Grantors”). Capitalized terms used but not defined herein have the meanings given to them in the Trademark Security Agreement (as defined below), whether defined directly therein or by reference to another agreement.

WHEREAS, pursuant to that certain First Lien Security Agreement, dated as of August 31, 2018, by and among the Grantors, the Agent and certain other parties (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantors executed and delivered in favor of the Agent that certain First Lien Grant of Security Interest in Trademarks, dated August 27, 2019 (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office (“USPTO”) on August 28, 2019 at Reel/Frame 6731/0165 (with respect to Lucity, Inc.) and at Reel/Frame 6731/0227 (with respect to Tellus Safety Solutions, LLC);

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, each Grantor granted to the Agent, for the benefit of the Secured Parties, a Lien on and security interest in (the “Security Interest”) all of such Grantor’s right, title and interest in, to and under the Trademark Collateral, including, without limitation, the Trademarks of such Grantor listed on Schedule I hereto; and

WHEREAS, the Grantors have requested that the Agent terminate and release its Security Interest in the Trademark Collateral.


NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (i) terminates and cancels the Trademark Security Agreement, (ii) terminates, cancels, discharges and releases its Security Interest in the Trademark Collateral and (iii) re-assigns to each Grantor any right, title or interest it may have in or to the Trademark Collateral of such Grantor, in each case without recourse to the Agent and without representation or warranty of any kind.

Each Grantor (and any successor to such Grantor, including any person or entity hereafter holding any right, title or interest in and to the Trademark Collateral of such Grantor) is hereby authorized to record this Release with the USPTO with respect to the Trademark Collateral of such Grantor.
