**TERMINATION AND RELEASE OF INTELLECTUAL
PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of April 12, 2024 by **FIRST-CITIZENS BANK & TRUST COMPANY** (“**Bank**”), in favor of **LUMANU, INC.**, a Delaware corporation (“**Grantor**”).

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement, dated as of October 20, 2023 (the “**Agreement**”), granting to the Bank a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Trademarks (as defined in the Agreement), notice of which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on October 24, 2023 at Reel 8236, Frame 0102.

WHEREAS, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Patents and Trademarks as herein provided; and

WHEREAS, Grantor has requested that the Bank provide a document suitable for recording with the USPTO to evidence the release of the Bank’s security interests in and liens on the Patents and Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. *terminates the Agreement and releases, terminates and discharges fully all liens and security interests thereunder in Grantor’s right, title and interest in, to and under the Intellectual Property Collateral (as defined in the Agreement), including, without limitation, those trademarks and trademark applications identified in Schedule I hereto; and*
2. *authorizes and requests that this Termination and Release be recorded with the USPTO.*
