TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of April 15, 2024, by ROYAL BANK OF CANADA, an Alberta bank (in such capacity, together with its successors and assigns, “Administrative Agent”) in favor of WAWONA PACKING CO. LLC, a California limited liability company with an address at 7700 N Palm Ave, Suite 206, Fresno, CA 93711 and GERAWAN FARMING LLC, a California limited liability company with an address at 7700 N Palm Ave, Suite 206, Fresno, CA 93711 (each, a “Grantor” and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, each Grantor entered into a certain Trademark Security Agreement dated June 21, 2022 (the “Trademark Security Agreement”) with the Administrative Agent, notice of which was recorded on June 21, 2022 at the United States Patent and Trademark Office at Reel 7758, Frame 0687.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, each Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in all of each such Grantor’s right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks listed in Schedule A.


WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby terminates the Trademark Security Agreement and releases, terminates and discharges (in each case, without any recourse to, or any representation or warranty by, the Administrative Agent) any and all of its interest in the Trademark Collateral of the Grantors, and assigns, transfers and conveys to Grantors (in each case, without any recourse to, or any representation or warranty by, the Administrative Agent) the Security Interest in such intellectual property.
