Assignors further agree to: (a) cooperate with Assignee in the protection of the IP rights and prosecution and protection of foreign counterparts; (b) execute, verify, acknowledge and deliver all such further papers, including patent and trademark applications and instruments of transfer; and (c) perform such other acts as Assignee lawfully may request to obtain or maintain the IP and any and all applications and registrations for the IP in any and all countries.






