## INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT dated April 18, 2024 (as amended, amended and restated, supplemented or otherwise modified from time to time, this “IP Security Agreement”), is among QLIKTECH INTERNATIONAL AB, a company organized under the laws of Sweden (the “Grantor”), and Morgan Stanley Senior Funding, Inc., as Collateral Agent for the Secured Parties (as defined in the Credit Agreement referred to below).

WHEREAS, reference is made to that certain (i) Credit Agreement, dated as of October 26, 2023 (as amended, restated, amended and restated, supplemented, replaced, refinanced or otherwise modified from time to time, the “Credit Agreement”), among Project Alpha Intermediate Holding, Inc., a Delaware corporation (the “Borrower”), Project Alpha Intermediate II Holding, Inc., a Delaware corporation (“Holdings”), each lender from time to time party thereto, each L/C Issuer party thereto and Morgan Stanley Senior Funding, Inc., as Administrative Agent, Collateral Agent and an L/C Issuer, and (ii) Security Agreement, dated as of October 26, 2023 (as amended, restated, amended and restated, supplemented, replaced, refinanced or otherwise modified from time to time, the “Security Agreement”), among the Grantors from time to time party thereto and the Collateral Agent. Capitalized terms defined in the Credit Agreement or the Security Agreement and not otherwise defined herein are used herein as defined in the Credit Agreement or the Security Agreement, as applicable (and in the event of a conflict, the applicable definition shall be the one given to such term in the Security Agreement).

WHEREAS, under the terms of the Security Agreement, the Grantor has granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantor, and has agreed thereunder to execute this IP Security Agreement for recording with the United States Patent and Trademark Office (“USPTO”) and/or the United States Copyright Office (“USCO”), as applicable.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor agrees with the Collateral Agent as follows:

A. Grant of Security. The Grantor hereby pledges to the Collateral Agent, for the benefit of the Secured Parties, and the Grantor hereby grants to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all of the Grantor’s right, title and/or interest in and to the following, whether now owned or hereafter acquired by the Grantor (the “Collateral”):

a. all patents, patent applications, utility models, statutory invention registrations and all inventions claimed or disclosed therein and all improvements thereto that are, in each case, material and registered or applied for under the laws of the United States of America, and the patents and applications set forth in Schedule A hereto;

b. all trademarks, trademark applications, service marks, domain names, trade dress, logos, designs, slogans, trade names, business names and corporate names that are, in each case, material and registered or applied for under the laws of the United States of America, and the registrations and applications set forth in Schedule B hereto (provided that no security interest shall be granted in United States intent-to-use trademark applications prior to the filing and acceptance of a “Statement of Use” pursuant to Section 1(d) of the Lanham Act or an “Amendment to Allege Use” pursuant to Section 1(c) of the Lanham Act with respect thereto, to the extent that, and solely during the period, if any, in which, the grant of a security interest therein would impair the validity or enforceability of any registration that issues from such intent-to-use application under applicable federal law), together, in each case, with the goodwill symbolized thereby;

c. all copyrights, including without limitation, copyrights in Computer Software, internet websites and the content thereof, that are, in each case, material, and registered or applied for under the laws of the United States of America, and the copyright registrations and applications set forth in Schedule C hereto;

d. all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing;

e. any and all claims for damages or injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages or injunctive relief; and

f. any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and Supporting Obligations relating to, any and all of the foregoing; provided that notwithstanding anything to the contrary contained in the foregoing clauses (a) through (f), the security interest created hereby shall not extend to, and the term "Collateral" shall not include, any Excluded Property. For the avoidance of doubt, and notwithstanding anything to the contrary set out in this IP Security Agreement: (i) nothing in the grant of a security interest or collateral assignment under this Agreement or otherwise herein is intended to effect, or shall be construed as, an absolute assignment or assignment of title of Collateral from the Grantor to Collateral Agent and; (ii) the Grantor shall be free to deal with, use, license or otherwise commercialize the Collateral (including allowing any intellectual property rights included therein to lapse if the Grantor determines such Collateral are no longer material to the Grantor's business) in any manner not prohibited by the Loan Documents until an Acceleration Event (as defined in Exhibit A to the Credit Agreement) has occurred and is continuing; (ii) no security will be granted over any Collateral which cannot be secured under the terms of the relevant licensing agreement or is otherwise subject to other third-party rights or consents; and (iii) the Grantor shall not be required to procure any changes to, or corrections of filings on, external registers or otherwise register or apply to register any intellectual property rights or escrow any source code.

B. Security for Obligations. The grant of a security interest in the Collateral by the Grantor under this IP Security Agreement secures the payment of all Secured Obligations of the Grantor now or hereafter existing under or in respect of the Secured Documents (as such Secured Documents may be amended, restated, amended and restated, supplemented, replaced, refinanced or otherwise modified from time to time (including any increases of the principal amount outstanding thereunder)). Without limiting the generality of the foregoing, this IP Security Agreement secures, as to the Grantor, the payment of all amounts that constitute part of the Secured Obligations that would be owed by the Grantor to any Secured Party under the Secured Documents but for the fact that they are unenforceable or not allowable due to the existence of a bankruptcy, or reorganization or similar proceeding involving a Loan Party. In no event will the grant of a security interest be provided by way of assignment, legal mortgage or transfer of ownership of the Collateral.

C. Swedish Law Limitations. The obligations of the Grantor under this IP Security Agreement (a) shall be limited if (and only if) and to the extent required by an application of the provisions of the Swedish Companies Act (Sw. Aktiebolagslagen (2005:551)) (the "Swedish Companies Act") in force from time to time regulating distribution of assets (including profits and dividends and any other form of transfer of value (Sw. värdeöverföring) within the meaning of Chapter 17, Sections 1-4 (or their equivalents from time to time) of the Swedish Companies Act, provided, in each case, that all steps open to the Grantor and all its shareholders to authorise its obligations under this IP Security Agreement have been taken, and it is understood that the security in respect of such obligations only applies to the extent permitted by the

above mentioned provisions of the Swedish Companies Act and (b) shall not extend to any obligations or liabilities of (i) any immediate shareholder of the Swedish companies, which is not an entity incorporated within the European Economic Area (a "Non-EEA Parent"), or (ii) any entity over which that Non-EEA Parent, alone or together with any other person, within the meaning of Chapter 21, Section 1, paragraph 5 of the Swedish Companies Act, has a controlling influence (Sw. bestämmande inflytande).

D. Recordation. Grantor authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks, as applicable, record this IP Security Agreement with the USPTO and/or USCO.

E. Execution in Counterparts. Sections 10.11 (Counterparts) and 10.21 (Electronic Execution of Assignments and Certain Other Documents) of the Credit Agreement are hereby incorporated by reference, mutatis mutandis.


F. Grants, Rights and Remedies. This IP Security Agreement has been entered into in conjunction with the provisions of the Security Agreement. The Grantor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Collateral Agent with respect to the Collateral are more fully set forth in the Security Agreement. In the event of any conflict between the terms of this IP Security Agreement and the terms of the Security Agreement, the terms of the Security Agreement shall govern.

G. Governing Law; Jurisdiction. SECTION 10.15 (GOVERNING LAW; JURISDICTION; ETC.), SECTION 10.16 (SERVICE OF PROCESS) AND SECTION 10.17 (WAIVER OF RIGHT TO TRIAL BY JURY) OF THE CREDIT AGREEMENT ARE HEREBY INCORPORATED BY REFERENCE, MUTATIS MUTANDIS.
