**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated April 15, 2024 by BANK OF MONTREAL, a Canadian chartered bank acting through its Chicago branch, with its mailing address at 105, St. Jacques Street, 3rd Floor, Montreal, Quebec H2Y 1L6 (“*Secured Party*”);

WITNESSETH:

WHEREAS, BEST FRIENDS PET CARE, INC., a Delaware corporation (the “*Debtor*”) with its principal place of business and mailing address at 535 Connecticut Ave, Suite 305, Norwalk, Connecticut 06854, and Secured Party were parties to a certain Trademark Collateral Agreement dated April 2, 2015 between Debtor and Secured Party which was recorded in the United States Patent and Trademark Office on April 6, 2015 at Reel 5492, Frame 0765 (the “*Agreement*”), pursuant to which Debtor granted to Secured Party, a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the “*Trademark Property*”); and

WHEREAS, Debtor has requested that Secured Party release its security interests in the Trademark Property and reassign the same to Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

Secured Party hereby releases its security interests in, and hereby reassigns, grants and conveys to Debtor, without any representation, warranty, recourse or undertaking by Secured Party, all of its right, title and interest, if any, in and to each trademark, trademark registration, and trademark application listed on Schedule A hereto, including:


(i) Each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application and all extensions and renewals thereof; and

(ii) All proceeds of the foregoing, including without limitation (x) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing and (y) any and all claims and causes of action by the Debtor against third parties for damages, restitution and injunctive and other legal and equitable relief by reason of past, present or future infringement, dilution, misappropriation, violation, misuse, breach or default of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right but no obligation to sue for and collect, or otherwise recover, said damages.
