TERMINATION AND RELEASE OF
FIRST LIEN SECURITY INTEREST IN TRADEMARKS

This Termination and Release of First Lien Security Interest in Trademarks (“Release”) is made as of April 25, 2024, by UBS AG, STAMFORD BRANCH, a Switzerland corporation (in such capacity, together with its successors and assigns, the “Administrative Agent”) in favor of FIRSTLIGHT FIBER, INC., a Delaware corporation (f/k/a TVC ALBANY, INC., a Delaware corporation, OXFORD COUNTY TELEPHONE AND TELEGRAPH COMPANY, a Maine corporation, BAYRING COMMUNICATIONS, INC., a New Hampshire corporation, SOVERNET, INC., a Vermont corporation, SOVERNET FIBER CORP., a Delaware corporation, and 186 COMMUNICATIONS, LLC, a New Hampshire limited liability company) (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain First Lien Trademark Security Agreement dated July 23, 2018 (the “Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on July 24, 2018 at the United States Patent and Trademark Office at Reel 6412, Frame 0469.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in all of such Grantor’s right, title and interest in and to the Trademark Collateral, including without limitation the Trademark Registrations and Trademark Applications listed in Schedule A.



WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges (in each case, without any recourse to, or any representation or warranty by, the Administrative Agent) any and all of its interest in the Trademark Collateral of the Grantors, and assigns, transfers and conveys to Grantors (in each case, without any recourse to, or any representation or warranty by, the Administrative Agent) any interest in such intellectual property, including the Security Interest and any other liens.
